ISOTeam inks game changing tech collaboration to facilitate building façade inspections

• Partnership with H3 Dynamics will see the Group deploying AI and drone technology for

building façade inspections.

Advantages include higher efficiency and safety, increased cost effectiveness and reduced

reliance on labour.

Collaboration is expected to reap benefits from legislative amendments passed in March 2020

that now require building façade to be inspected every seven years.

SINGAPORE, 22 October 2021 - ISOTeam Ltd. ("ISOTeam" or together with its subsidiaries, the

"Group"), an established and leading player in Singapore's building maintenance and estate upgrading

industry, today announced that its wholly-owned subsidiary, ISOTeam Green Solutions Pte. Ltd.

("IGS"), has entered into a five-year collaboration agreement with H3 Dynamics Pte Ltd ("H3

Dynamics") that will see IGS being appointed as the exclusive master agent for H3Zoom by H3

Dynamics' suite of products and services for building façade inspections.

H3Zoom by H3 Dynamics is the global artificial intelligence ("AI") and robotics services arm of H3

Dynamics that turns unstructured data from physical structures into digital and interactive reports via

a holistic management platform. Headquartered in Singapore, H3Zoom by H3 Dynamics covers the

entire inspection lifecycle starting with the deployment of autonomous drones with specialised sensor

payloads to conduct inspections of building facades based on a pre-established flightpath. That data

is then processed using AI to detect common defects such as cracks and corrosion.

H3 Dynamics is founded by Mr Taras Wankewycz, who is also co-founder of Nasdag-listed Hyzon

Motors Inc.. The company recently announced it raised US\$26 million in Series B funding and investors

included Mirai Creation Fund, EDBI (the investment arm of the Singapore Economic Development

Board), as well as ACA investors, Capital Management Group, the Grosvenor Group, Audacy Ventures,

Ascent Hydrogen Fund and French strategic investors ATEQ¹.

This collaboration is expected to reap benefits from legislative amendments passed in March 2020

that now require the façade of buildings that are over 13m tall and more than 20 years of age to be

inspected every seven years. Under this Periodic Facade Inspection ("PFI") regime, 4,000 buildings

are expected to be inspected annually.²

Under the agreement, the two parties will work together exclusively for Housing and Development

Board ("HDB"), town councils as well as commercial and condominium building façade inspection

projects that are secured by ISOTeam; and, non-exclusively for other projects. ISOTeam will also be

the master agent to market H3Zoom by H3 Dynamics' façade inspection products and services to other

parties for HDB block inspections.

H3Zoom by H3 Dynamics will conduct drone operations, offer access to its automated AI analytics

platform to building owners, and provide ISOTeam with engineer-reviewed data that the Group will

use to carry out façade repairs and other restoration works.

Executive Director and Chief Executive Officer, Mr Anthony Koh (许统发), said: "Our collaboration

with H3 Dynamics is a game changer for the industry as the use of drones will replace the traditionally

labour-intensive way of setting up gondolas and doing inspections manually. This new method is

efficient, safe, cost effective and also alleviates a little bit of the manpower shortage issues that the

construction sector has been facing as a result of tighter border controls. This partnership opens up

opportunities for H3 Dynamics and ISOTeam to explore other areas where we can use this technology

to reduce our industry's over-reliance on labour. This new way to inspect buildings causes less

inconvenience to residents and building owners and is energy efficient, which is in line with our

corporate mandate to continuously introduce green methodologies into our operations.

"Because of the PFI, building inspection now has to take place every seven years, which means it will

also become another recurring source of income for ISOTeam, just like the repainting of HDB blocks

which occurs every five years."

In the Straits Times article "Building owners urged to use drones for façade inspections as new BCA

quidelines rolled out" dated 21 October 2021, it was mentioned that there were at least 30,000

buildings slated for inspection over the next seven years and that façade inspectors have been urged

to tap drone technology to do so.

To-date, ISOTeam has secured three building façade inspection projects. The Group has also tendered

for close to \$\$2.0 million worth of public sector projects and is cautiously optimistic about the

competitiveness of its bids.
