ISOTeam's orderbook hits S\$182.4 million with S\$21.4 million in new projects; Wins include one of its largest Renewable Solutions projects to-date

SINGAPORE, 28 June 2024 – **ISOTeam Ltd.** ("**ISOTeam"** and together with its subsidiaries, the "**Group"**), an established and leading player in Singapore's building maintenance and estate upgrading industry has secured seven new projects worth approximately S\$21.4 million. With the latest wins, the Group's order book stands at S\$182.4 million.

The Group secured two Renewable Solutions projects totalling \$\$12.9 million for the installation of solar photovoltaic systems for the Jurong Town Corporation ("JTC") and the Housing and Development Board ("HDB") residential blocks. Notably, one of the projects is the largest Renewable Solutions projects for the Group since it won the job for Singapore's largest offshore floating solar farm off the Straits of Johor.

The new contracts also included three Addition and Alteration ("A&A") projects worth S\$6.9 million that is expected to be completed by April 2025. The A&A works are slated for Ang Mo Kio Town Centre and a factory building in Singapore. In addition, the Group bagged a S\$0.2 million Coating and Painting ("C&P") project and a S\$1.4 million Landscaping ("L&S") project which is expected to be completed by April 2025 and June 2027 respectively.

Group Executive Director and Chief Executive Officer, Mr Anthony Koh (许统发), said: "Our order growth momentum has been very encouraging as we hit our second half for FY2024, signalling the continued revival of both ISOTeam and Singapore's built environment sector. On a year-on-year basis, this sector contributes to about 3% to 5% of Singapore's total GDP, which was \$\$673 billion in 2023.¹ We hope to capture more opportunities from this sizable market as our operational efficiency levels improve further through greater adoption of technology and digitalisation. In addition, we will continue to pursue more opportunities in our Renewable Solutions business segment."
