## ISOTeam secures \$\$36.4 million in new projects; Maintains robust order book of \$\$188.7 million

**SINGAPORE, 7 February 2025** – **ISOTeam Ltd.** ("**ISOTeam"** and together with its subsidiaries, the "**Group**"), an established and leading player in Singapore's building maintenance and estate upgrading industry has secured 25 new contracts worth a total of S\$36.4 million. These latest project wins have strengthened the Group's order book to S\$188.7 million to date, reinforcing its continued growth momentum and strong market position.

The Group also won two Interior Design ("**ID**") jobs worth S\$0.6 million and two landscaping contracts valued at S\$1.1 million which are expected to be completed by June 2025 and October 2026 respectively.

Group Executive Director and Chief Executive Officer, Mr Anthony Koh (许统发), said: "We see strong growth momentum in our order book, driven by government-led upgrading projects in mature estates. Key opportunities up ahead for ISOTeam include HDB's Green Towns Programme, which will roll out heat-reflective paint to all HDB estates by 2030¹, and Singapore's expanding housing stock, with 102,300 Built-to-Order flats launched from 2021 to 2025². With mandatory repainting every five years, these initiatives create significant growth opportunities for us."
