AWARD OF CONTRACTS

The Board of Directors of ISOTeam Ltd. (the “**Company**”, and together with its subsidiaries, the “**Group**”) wishes to announce that the Group has secured the following projects, which are worth approximately S\$22.5 million in aggregate:

- (1) 3 Coating and Painting (C&P) projects with a total contract value of approximately S\$2.1 million¹, which are expected to be completed by March 2026**

These include C&P works at Robinson Road, F1 Pit Building and Integrated Transport Hub.

¹Includes an approximately S\$1.8 million contract to be executed pursuant to a letter of intent received by the Company.

- (2) 4 Addition and Alteration (A&A) projects with a total contract value of approximately S\$12.4 million, which are expected to be completed within 24 months**

These include A&A works at Kaki Bukit and Bedok Planning Area.

- (3) 1 Interior Design (ID) project with a total contract value of approximately S\$0.1 million, which is expected to be completed by December 2025**

This includes ID works at Rifle Range Road.

- (4) 4 Repair and Redecoration (R&R) projects with a total contract value of approximately S\$7.7 million, which are expected to be completed by April 2026**

These projects refer to R&R works at Yio Chu Kang Division, Geylang Serai Division, Jalan Kayu Division and Belle Vue Residences.

- (5) 1 Renewable Solution (RS) project with a total contract value of approximately S\$0.2 million, which is expected to be completed within 24 weeks**

This project refers to RS works at Sungei Kadut Street.

Including the abovementioned contracts, the Group's current order book stands at approximately S\$181.1 million as at the date of this announcement, and barring unforeseen circumstances, the contracts awarded are expected to progressively contribute to the Group's financial performance.

None of the Directors or controlling shareholders of the Company has any interest, direct or indirect, in the contracts secured, other than through their respective shareholdings (if any) in the Company.
