## ISOTeam secures new contracts worth S\$22.5 million to be completed within 24 months

## These contracts include:

- (3) Three Coating and Painting projects at Robinson Road, at the F1 Pit Building and at the Integrated Transport Hub worth approximately S\$2.1 million<sup>3</sup>, which are expected to be completed by March 2026;



(5) Four Addition and Alteration projects at Kaki Bukit and Bedok Planning Area worth approximately S\$12.4 million, which are expected to be completed within 24 months.
