**SUCCESSFUL CLOSE OF 3-MONTH SERIES 003 COMMERCIAL PAPER ON THE DIGITAL SECURITIES PLATFORM SDAX– S\$7.54 MILLION GROSS PROCEEDS RAISED**

The Board of Directors (the "**Board**") of ISOTEAM Ltd. (the "**Company**" and its subsidiaries, the "**Group**") is pleased to announce that the 3-month Series 003 SDAX Issuance launched on 9 December 2025 had closed on 19 December 2025 at 5:40 p.m. (Singapore time) and has received strong demand from investors, with the Company raising an aggregate gross amount of S\$7.54 million from accredited investors and institutional investors. The digital securities to be issued by the Company to the subscribers of the 3-month Series 003 SDAX Issuance will be issued on the SDAX digital platform on 23 December 2025.

Amongst the subscribers of the 3-month Series 003 SDAX Issuance, Mr Ng Cheng Lian, Mr Koh Thong Huat and Mr Foo Joon Lye had, through ADD Investment Holding Pte. Ltd.<sup>(1)</sup>, subscribed for S\$500,000, amounting to 6.63% of the 3-month Series 003 Issuance. Mr Ng Cheng Lian is the Executive Chairman and Director of the Company, Mr Koh Thong Huat is the Executive Director and Chief Executive Officer of the Company and Mr Foo Joon Lye, by virtue of his interest in ADD Investment Holding Pte. Ltd., is a controlling shareholder of the Company.

Each of them is therefore deemed to be interested in all the shares in the capital of the Company held by ADD Investment Holding Pte. Ltd. under Section 7 of the Companies Act 1967.*
